COVID- 19 Guidelines

- Arapahoe County Fairgrounds and Event Center requires all public Indoor Events of 500 more individuals **shall require proof of being fully vaccinated to be admitted into the Indoor Event.**
- Arapahoe County Fairgrounds and Event Center requires masks or face coverings in all indoor locations for anyone two years of age and older.
- Arapahoe County Fairgrounds and Event Center encourages the following:
 - ✓ Social distance and offer 6 feet or more distancing between all employees, customers, contractors and visitors.
 - ✓ Increase janitorial and sanitization of restrooms and highly touched surfaces.
 - ✓ Utilize touchless hand sanitizing stations at entrances and in high-traffic areas.
 - ✓ Touchless hand sanitizing stations will be located throughout all event spaces.
 - ✓ We encourage all attendees to stay home if sick or exhibiting COVID-19 symptoms. We encourage all attendees who have been in close contact with a person who has been suspected or confirmed to have COVID-19 (within 6ft for at least 10 minutes) to stay home and self quarantine.
- Arapahoe County Fairgrounds and Event Center and Arapahoe County urges you to take precautions consistent with your own comfort level.
- **Refunds & Cancellations:**
 - ✓ At 60 days from the Event Holder's contracted event, Event Holder and Arapahoe County Fairgrounds and Event Center staff will meet to discuss current guidelines of the facility.
 - ✓ At this time, the Event Holder has the discretion to cancel and receive a full refund, only if the current facility guidelines fall at or below level yellow (75 and fewer guests at one time, indoors).
 - ✓ The Event Holder, at this time, may also choose to host their event as originally contracted within whichever guidelines are in place at the time of the event.
 - ✓ Any other cancellation/refund requests will align with the original contracted policies.

It is understood that these guidelines are in addition to the Fairgrounds Policy Statement and are not all-inclusive.
